1	Tent the windows of training vehicle	AED 500
2	Conduct training using vehicle with technical defects resulted from traffic accident	AED 500
3	Use training vehicle licensed for another school or institution without permit from General Resources Authority in Ras Al Khaimah	AED 400
4	Park the vehicle outside the establishment's campus or the parking slots designated thereto after the end of work period	AED 400
5	Failure of the Training Facility to use contracts forms approved by the Authority	AED 500
6	Failure to maintain records and files of data and statistics and documents related to training activities, according to the systems approved by the Authority, and make the same available for perusal of Authority's employees, whether in papers or electronically	AED 500
7	Failure to allocate one or more experienced and competent instructor to explain traffic laws to trainers in languages determined by the Authority	AED 500
8	Non-provision of buildings, facilities, training tools and programs and system necessary thereto according to the specifications and conditions approved by the Authority in this regard	1- A warning notice of not more than 6 months 2- Close the establishment for one month 3- Extend closing the establishment in case of repetition
9	Non-commitment to give the trainee the determined training sessions and lectures	AED 1000
10	Failure to notify Licensing Authority of the school's desire to stop practicing the activity, according to the procedures placed by the Authority on this regard.	AED 1000
11	Refrain from providing the Authority's competent employees with required data and information	AED 500

1	Non-commitment of the trainer to conduct vehicles driving training through one of the licensed training establishments	AED 500
2	Non-commitment to the full duration of training session	AED 200
3	Conduct training in places where training is prohibited	AED 200
4	Existing of more than one student in the vehicle during practical driving training	AED 500
5	Seek the help of the trainee in pushing the vehicle when it breaks down	AED 500
6	Use phone during training	AED 300
7	Turn on radio and music players during training	AED 300
8	Train the student more than two sessions on one day without his consent	AED 400
9	Eat and drink in the vehicle during training	AED 400
10	Smoking during training	AED 500
11	Failure of the trainer to abide by cleanliness and well dress.	AED 200
12	Prove providing sessions to the trainee on contrary to the truth	AED 1000
13	Fix training times for the trainee without referring to training facility	AED 200
14	Carry personal items in the vehicle during training	AED 200
15	Take training card from the student and keep the same with the trainer	AED 500
16	Trainers obtain personal benefits from the trainees	Give warning notice to the trainer or suspend him for a maximum period of six months, it is permissible also to suspend the file of the trainee for one year
